1 Advance consultation

If you wish to use the copyrighted material on this site beyond the scope of "private use" or "quotation" under the Copyright Act, please contact the following contact in advance after the specific use has been decided. We will confirm the details of your use individually.

- 2 Advance confirmation of a set of application documents
 - After confirming in "1 Advance consultation", please send a set of draft application documents (application form (draft), manuscript (draft), etc.) by e-mail. Our section will individually check the contents of the application at the draft stage.
- 3 Examination of formal application documents
 - After checking in "2 Advance confirmation of a set of application documents", affix the seal of the representative on the application form and mail the set of application documents. It takes about one month from the time the formal application documents are received to our department until the permission to use the copyrighted work is approved, as the application will go through an examination at the Tokyo Metropolitan Government Office.
- 4 Sending the approval letter

When the purpose and method of use are deemed appropriate and the examination is completed, an approval letter will be issued in the name of the Governor of Tokyo.
